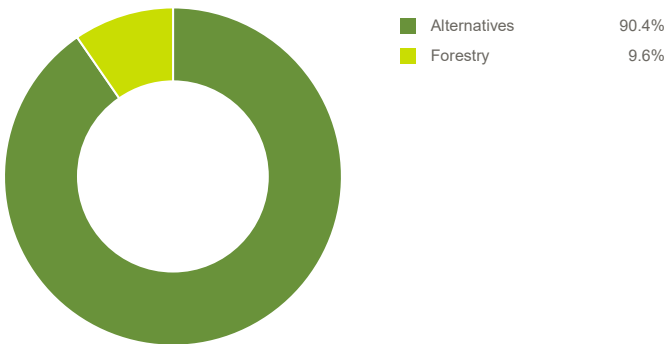


FUND DESCRIPTION

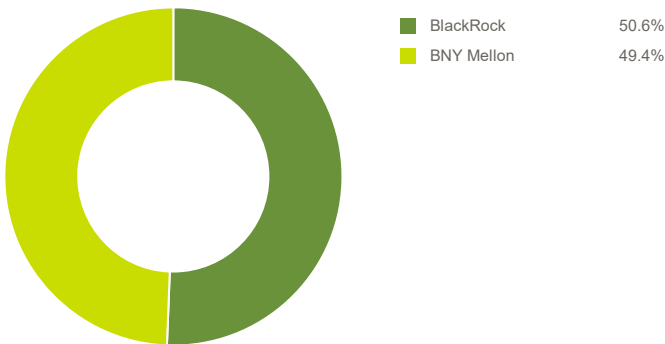

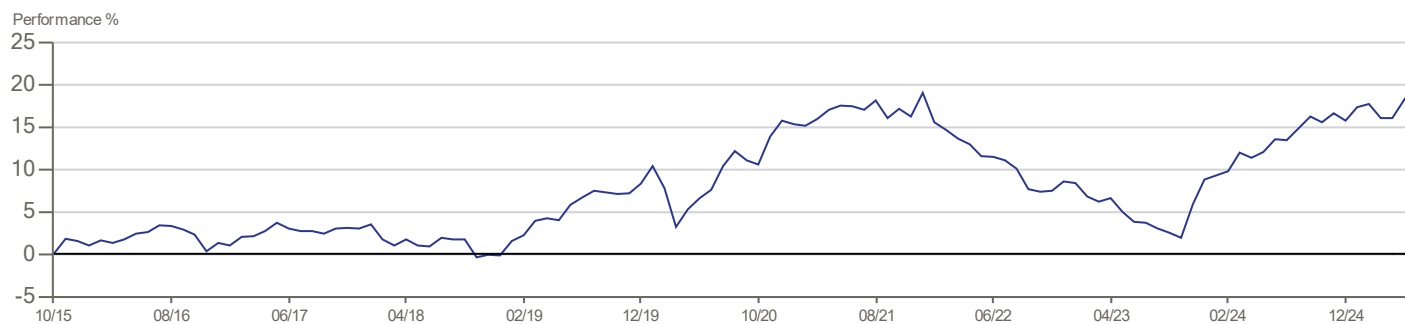
